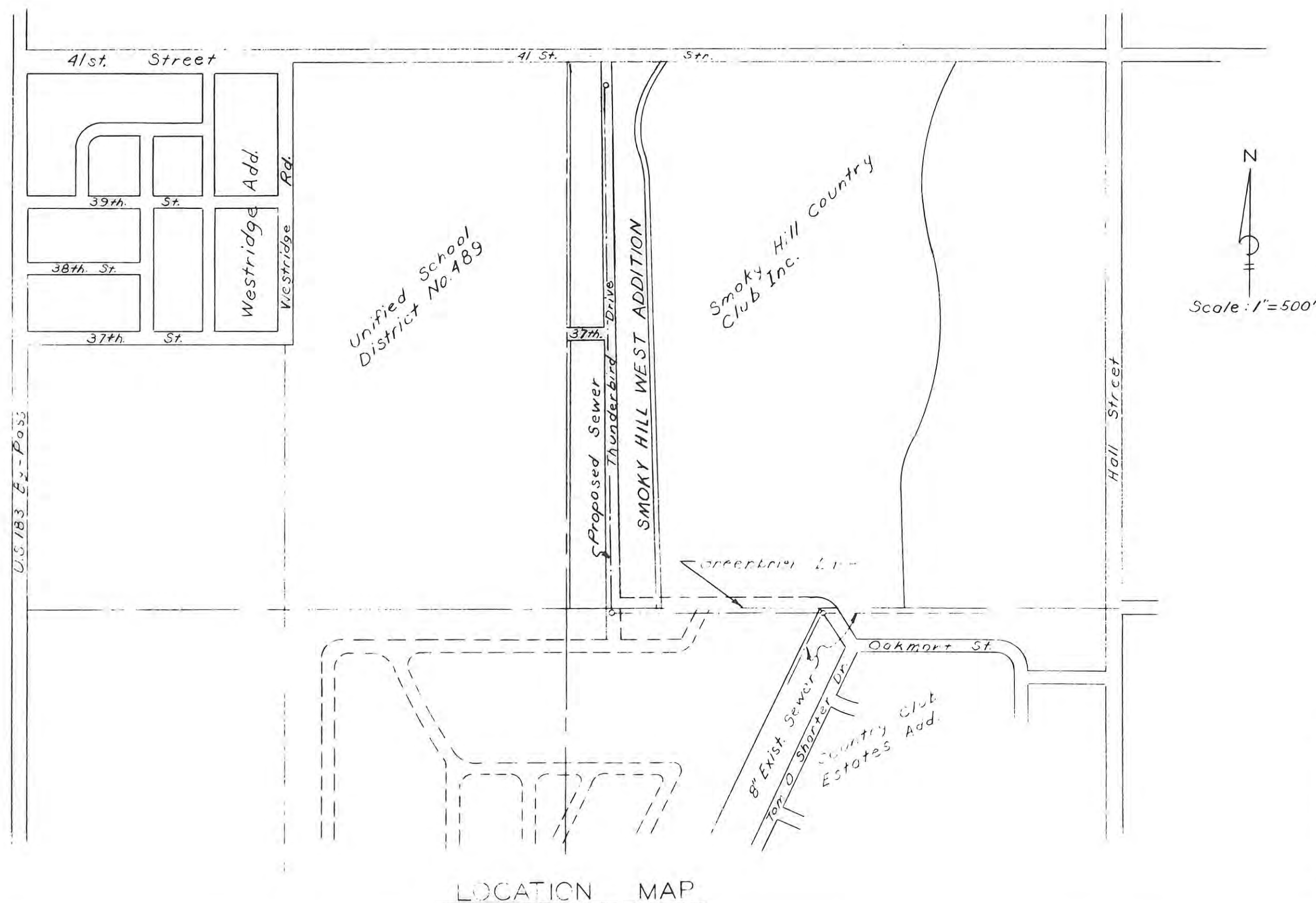
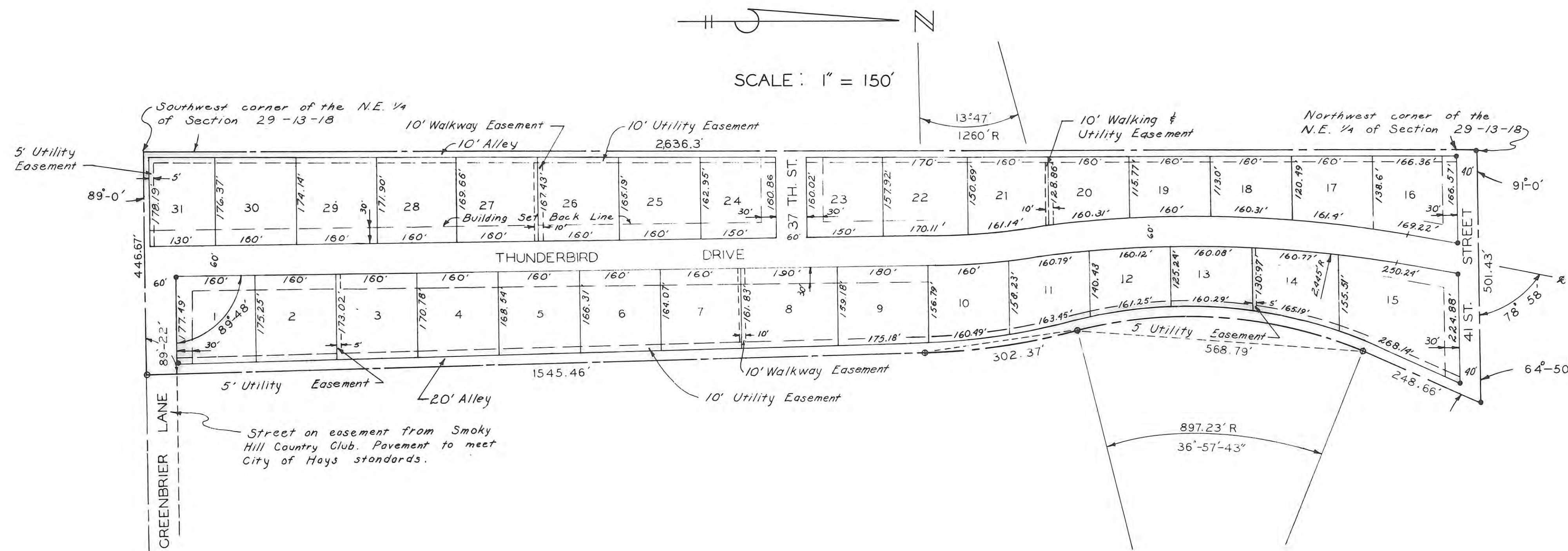


SMOKY HILL WEST ADDITION

AN ORDINANCE VACATING ALL ALLEYS LOCATED IN SMOKY HILL WEST ADDITION TO THE CITY OF HAYS, KANSAS, RESERVING UNTO SAID CITY OF HAYS, KANSAS, SUCH RIGHTS OF WAY AND EASEMENTS AS MAY BE NECESSARY FOR UTILITY PURPOSES.

LEGAL DESCRIPTION:

A tract of land in the Northeast one-quarter of Section 29, Township 13 South, Range 18 West of the Sixth Principal Meridian, Ellis County, Kansas and further described as follows:

Beginning at the Northwest corner of the Northeast one-quarter of Section 29; thence South along the West line of said Northeast one-quarter, a distance of 2,636.30 feet to the Southwest corner of said Northeast one-quarter; thence East along the South line of said Northeast one-quarter, a distance of 446.67 feet; thence North with an internal angle of 89 degrees 22 minutes, a distance of 1,515.46 feet; thence left on a curve (Radius 1,260 feet, internal angle of 13 degrees 47 minutes), a chord distance of 302.37 feet; thence right on a curve (Radius 897.23 feet, internal angle of 36 degrees 57 minutes 43 seconds), a chord distance of 568.79 feet; thence Northeasterly a distance of 248.66 feet to the point on the North line of the Northeast one-quarter of Section 29; thence West along said North line, a distance of 501.43 feet to the Northwest corner of the said Northeast one-quarter and the point of beginning. Contains 25.88 acres.

STREET, ALLEY AND EASEMENTS:

Street, alley and easements shown on this plat and not heretofore dedicated for public and private use are hereby dedicated for public and private use and may be employed for the purpose of installing, repairing and maintaining all public and private utilities now or hereafter.
